Advance eLearning

<u>The Advance Project</u> offers a range of learning options for <u>GPs</u>, <u>general practice nurses</u>, and <u>general practice managers</u> to develop their knowledge of, and skills in using screening tools to support the provision of palliative care and advance care planning in everyday general practice.



caring@home

The <u>caring@home</u> project aims to train nurses to support and enhance the ability of lay caregivers to manage subcutaneous medications thereby assisting palliative patients access to timely symptom management.

End-of-Life Essentials Education Modules

These <u>Education Modules</u> are designed to assist clinical staff working in acute hospitals in delivering end-of-life care.



End of Life Law for Clinicians (ELLC)

<u>This project</u> helps clinicians learn about end-of-life law and the effects this has on end-of-life care and palliative care for patients.



Palliative Aged Care Outcomes Program (PACOP)

<u>PACOP</u> supports optimal end-of-life care for residents in aged care homes and their families. The program offers two modules - the foundational Profile Collection and the Outcomes Collection. The Outcomes Collection is a palliative model of care and provides an Assess, Respond, Plan protocol to ensure residents' palliative care needs are monitored and addressed in a timely manner.



The Program of Experience in the Palliative Approach (PEPA)

<u>PEPA</u> provides health professionals and care providers with an observational placement in a palliative care service as well as access to workshops in the palliative approach. Reverse placements where a specialist palliative care staff member travels to the residential aged care service to facilitate palliative care learning area is also available.



TEL: Talking End of Life... with people with intellectual disability

<u>TEL</u> provides online education via 12 modules covering the role of disability support workers, key issues on dying and death, and supporting the needs of people with intellectual disability as they plan for end of life.
